2009 Shock Society Program Overview

The 32nd Annual Conference on Shock will convene in San Antonio,

Texas June 6-9, 2009. We were fortunate to have 267 submitted abstracts with a wealth of exciting, cutting-edge science. The Program will include workshops and symposia presented by leading investigators in timely subjects, mini-symposia representing the best abstracts, for the most popular topics, a mini-symposium with short presentations of the best posters, the New Investigator Award competition, 209 posters presented throughout three sessions, a special

luncheon discussion, and the address by our Presidentelect. The workshops and symposia will be:

Stem Cell Rescue co-chaired by Dan Meldrum, M.D. and Irshad Chaudry, Ph.D. joined by Laura Suggs, Ph.D., Charles Cox, M.D., David Hackam, M.D., and Muhammad Ashraf, Ph.D. The presentations cover stem cell delivery systems, stem cell mechanisms of protection, anti-inflammatory effects of stem cells, and stem cell therapy in trauma.

Epigenetics in Inflammation co-chaired by Ani Banerjee, Ph.D. and Edward Abraham, M.D., joined by Andrew Chess, Ph.D. The discussions include an overview of epigenetics, interchromosomal interactions, and mi RNA therapy in shock.

Virtually Virchow: Inflammation meets Coagulation cochaired by Dan Remick, M.D., and Deborah Stearns-Kurosowa, Ph.D., joined by Jamey Marth, Ph.D., Jill Sondeen, Ph.D., Markus Huber-Lang, M.D., Judith Hellman, M.D., and Ed Abraham, M.D. The topics include the interaction of complement and coagulation in early trauma, prehospital factor VII a for uncontrolled hemorrhage, the role of the Ashwell-Morell receptor in sepsis, TLR-2 pathways in sepsis induced endothelial activation, and the role of coagulation factors in PMN activation and clearance.

Innate/Adaptive Counterpoise co-chaired by Jim Lederer, Ph.D. and Eugen Faist, M.D., joined by De Yang, M.D., Ph.D., Timothy Billiar, M.D., Edward Sherwood, M.D., and Alfred Ayala, Ph.D. The discussions include alarmins in the injury response, endogenous response to injury, immune consequence of trauma, costimulatory receptors in sepsis, and the cellular immune response to sepsis.

Inflammation and the Host Response co-chaired by Ron Maier, M.D. and Linc Moldawer, Ph.D., joined by Wen Xiao, Ph.D., David Camp, Ph.D., Carol Miller-Graziano, Ph.D., Mehmet Toner, Ph.D., Perren Cobb, M.D., and Ronald Tompkins, M.D. This session will highlight some of the accomplishments of the Glue Grant and includes genomics of acute injury, genomic prediction of VAP, and proteomics of the innate immune system, mass spectroscopy proteomics, and microfluidics for cell subpopulations.

The New Investigators Award competition will consist of the top five qualified abstracts and there will be an additional session Oral Presentation By and For New Investigators. The mini-symposia include: Reviewer's Favorites', Gene Regulation, Growth Factors, Apoptosis, Intercellular Signaling, Intracellular Signaling, Immunomodulation, and Best Abstracts.

Scott Somers, Ph.D. will be coordinating the luncheon session: **Promoting Diversity in Research** and Dan Remick, M.D.'s address will be **Setting Goals to Get What We Want**.

Treasurer's Report

Given the severity of the current economic downturn and the

resulting volatility of the investment markets, I would like to take this opportunity to share with you some efforts taken to secure the monetary asset of our Society and to maintain stable funding support for awards and fellowships.

As of March 31, 2009, the Society has assets of \$641,670. The Society has taken prompt steps to ensure that our assets are fully guaranteed by the FDIC for the entire amount. The principal has placed into an interest-generating Money Market Fund (1.7-2.5% annual interest). A detailed 2008 income and expense report will be provided at the Council Meeting at the 32nd Annual Conference in San Antonio, Texas.

The prolonged economic crisis has affected the global health care system. As a consequence, we have not received substantial financial contributions from industrial or governmental sponsors for awards or support for our annual meeting. Nevertheless, the Shock Society has made a significant commitment to ensure continuity for annual funding of ongoing programs. This year the Society will award a Research Fellowship (\$60,000 over two years) to support the career development of new investigators in the areas of trauma, shock and sepsis. Also, the Society has increased the number and the monetary value of travel awards. The Society will provide 25 travel awards up to \$1000 each to allow the attendance of outstanding young investigators at our annual meeting.

As we plan the FY 2010 budget in the face of the economic uncertainty we are facing, the Society will remain focused on its highest priority to sustain research excellence. Thank you for your continued advocacy on behalf of the Shock Society.

Highlights of the February 2009 Shock Council Meeting

Several exciting new initiatives were adopted by Council. First, the Council voted to fund a 2-year 30K/year research fellowship as an interim replacement for the Novo Nordisk fellowship award that has been discontinued. The Society will use its own funds to provide this critical fellowship support for our membership's development. The Society will actively seek other corporate contributions to allow us to continue this Fellowship award in future years. A second new action is the appointment of the incoming Annual meeting program chair as cochairman of the preceding year's Annual meeting. This will facilitate transition from year to year, improve program planning, and accelerate meeting development. Dr. Coopersmith will be co-chair of the San Antonio meeting and Dr. Billiar will be co-chair of the 2010 Portland meeting.

Three finalist venues were selected for the 2011 Annual meeting. These are the Westin Waltham (Boston), the Crystal City or Westfields Marriotts (Washington DC) and the Marriott Waterside Norfolk (Virginia). These venues were selected to keep the maximum hotel cost below \$200/night as requested by our membership. In addition, these venues appeared to provide appropriate meeting space and recreation opportunities. The final venue selection will be made in Council after the areas are site visited by meeting management.

The last new activity reported was the solicitation of the membership for meeting sessions suggestions by Dr. Coopersmith, chair of the 2011 Annual meeting. Dr. Coopersmith has planned many other new meeting innovations which will be described in a later newsletter. The Council hopes to see a wide membership participation at the Annual meeting at San Antonio this year.
