# James Lederer, Ph.D. 2012 Program Chair

On behalf of the International Program Committee, we hope you are looking forward to

attending the 7<sup>th</sup> Congress of the International Federation of Shock Societies and the 35<sup>th</sup> Annual Conference on Shock. This year's committee put together an integrated international program with the primary aim of providing an international perspective on injury, shock, and sepsis research. The program includes plenary sessions and parallel symposia on topics that encompass new as well as ongoing shock research areas. We are also pleased to announce that Dr. Joost Oppenheim from the National Cancer Institute (NCI) will present a keynote address entitled "Alarmins can be Alarming!" at this year's meeting. As many of you know, Dr. Oppenheim is a long-standing pioneer of inflammation research and will share with us his expertise and insights on the host response to injuries and sepsis.

The session topics this year will include plenary sessions entitled; Shock Research from Around the Globe, The

Influence of Predisposing Conditions on the Pathophysiology of Injury and Sepsis, An International Perspective on New Treatments for Injury, Sepsis, and Organ Dysfunction, Nutritional Influences on Critical Injuries , and Endogenous Triggers of the Injury Response. The symposia topics will include; Traumatic Brain Injury: Prevalence, Diagnosis and Treatment, Pathways to Discovery, Cellular and Molecular Mediators of Injury and Shock, Alternative Medicine Approaches to Study and Treat Injury, Shock, and Sepsis, Resolution of the Injury Response, The Significance of Stem Cells to Injury Research and Therapy, and Cellular and Molecular Responses to Hemorrhagic Shock. In addition to the invited speakers, the top-scoring abstracts were placed within these sessions as oral presentations. The New Investigator Award session will include the top 5 finalists plus award-winning presentations from this year's European and Japan Shock Societies. Each day of the meeting will begin with 2 hour long poster sessions with continental breakfast to encourage fruitful discussions. We, the program committee, are confident that you will find this year's meeting at least as exciting as the traditional Presidential Fun Run on Monday morning.

I would like to thank the hard-working members of the Shock Society Program Committee for their thoughtful review of abstracts and for their help with organizing the sessions. These include Ping Wang, MD (2013 Chair), Charles Caldwell, PhD, Celeste Finnerty, PhD, Judith Hellman MD, Edmund Miller, PhD Marcin Osuchowski, DVM, PhD, Edward Sherwood, PhD, and Michael West, MD, PhD. This includes plenary sessions on shock research and treatments around the world including: endogenous triggers of the injury response, the influence of predisposing conditions and nutrition on outcomes. # Lorrie Langdale, M.D. Treasurer

I am happy to report that the Shock Society remains fiscally healthy. A detailed 2011 income and expense report will be provided at the

Council Meeting at the 35<sup>th</sup> Annual and International Conference in Miami, Florida.

As of February 2012, the Society had a bit over \$1 million in total assets with projected encumbrances of \$150,000 between now and the June meeting. This represents a remarkable recovery from a very stressful period not so long ago, as many long-standing members will recall. The current principal is distributed over several institutions in interest-generating Money Market Funds to ensure FDIC coverage. Because of the low yield of these accounts, the Council and society members voted to pursue in a more aggressive investment strategy while maintaining as much fluidity as possible. \$250,000, initially invested in a 1 year Certificate of Deposit, has recently been re-invested in a higher yield 36 month CD. An additional \$250,000 was invested in a mutual fund instrument through the Royal Bank of Canada Financial Management group. This fund is governed by a strict stop-loss strategy, limiting our overall potential risk, and can be accessed without penalty should the need arise. Fluctuations in the market have not yet yielded significant gains but as our economy recovers, I expect that we will reap substantial benefits.

Income from the Journal continues to be our primary source of revenue and a new contract, negotiated last spring, guarantees at least \$150,000 per year in Our primary expenses include our revenues. commitments to Strategem, Journal subscriptions for members, and meeting costs. A new contract with Stratagem was negotiated for 2011 through 2015 and we look forward to continuing the productive relationship that has made our meetings so successful. Strategem and the council have been trying to garner additional vendor support to offset meeting expenses this has proven to be challenging as the intimate (ie "small") scale that so many of us love about our meeting makes us less attractive to vendors. Fiscal development is integral to the evolving strategic plan for the Shock Society so if you have contacts or ideas, please contact our esteemed president, Dr. Buchman, or virtually any council member. We are all in this together so let's hear from YOU! See you in Miami!

I am also thankful to Connie Weldon, my Editorial Assistant, who has and continues to provide tremendous help in all aspects of the journal. My special thanks go to Mr. John Ewers, our Senior Publisher, and to Rosemary Hutzler, our Production Editor, Lippincott Williams & Wilkins (LWW), for their kind help pertaining to publication.

The web site, ScienceByte, was made available by Matthias Redl for online submission and processing of manuscripts for SHOCK for a long period of time. ScienceByte was extremely useful and allowed a simplified and fast way to upload manuscripts. Since September 2011, the manuscript submission site has been changed from ScienceByte to Editorial Manager, which is managed by LWW. There are many features on Editorial Manager which were unfortunately not available on ScienceByte, and I will greatly appreciate the authors' indulgence in their submission of manuscripts through Editorial Manager, although it requires more author input than in the previous system. The many additional features, such as Deep Links, aid and improve the author submission process. Furthermore, the ability to send user name/password from the user's record, quick links to search pages, file attachment as ad hoc letters, automated author reminders and such other features, necessitated our

switching to Editorial Manager. I express my sincere thanks, gratitude and appreciation to Matthias Redl for all the hard work and kind help he provided the journal and me through ScienceByte.

I am pleased to inform you that the Publication Committee Chair Dr Charles Lang and his Committee approved the appointment of the following Editorial Board members to Associate Editors. These include: Timothy Buchman, Frederick Moore, and Basilia Zingarelli. The Publication Committee also approved the appointment of Daniel Meldrum as Associate Editor-in-Chief, and Christoph Thiemermann as Senior Associate Editor, Europe. The following individuals have agreed to serve on the Editorial Board of SHOCK, effective 2011. These include: Derek Angus, Anirban Banerjee, Hobart Harris, Laurie Kilpatrick, Rosemary Kozar, Reinaldo Salomao, and Huang-Ping Yu.
