With great pleasure we invite all of you to attend the 36th Annual Conference on Shock on June 1-4, 2013 in San Diego, CA. We put together an exciting

program aimed to provide latest perspectives in the mechanism and therapeutics of injury related to shock, sepsis, and ischemia-reperfusion injury. The program includes plenary and parallel symposia on topics that cover new and ongoing studies in shock research.

We are pleased to announce that Dr. Kevin Tracey from the Feinstein Institute for Medical Research will present the keynote address entitled "*Reflex integration of Inflammasome Responses*". Dr. Tracey is a pioneer in inflammation research and will share with us his expertise in the mechanism of integration of the nervous system in controlling the immune responses. The Presidential Address will be delivered by our President-Elect, Robert N. Cooney, MD. Dr. Cooney will offer his insight on the prevention of multiple systems organ failure.

Inflammatory Mediators: History and Perspectives,

co-chaired by Alfred Ayala, PhD and Craig M. Coopersmith, MD. Speakers include Clifford S. Deutschman, MD, Melanie J. Scott, MD, PhD, Weng-Lang Yang, PhD, Michelle J. Henry-Stanley, PhD, Charles H. Lang, PhD, Philip A. Efron, MD, Xianzhong Meng, MD, PhD, and Kevin W. McConnell, MD. The presentations will focus on inflammation and mediators in laboratory and clinical settings, newly-discovered mediators, microbial biofilms, myokines, innate immunity, and immune trafficking.

A Pro-Con Debate: Is Rodent Model Relevant to Human Disease? chaired by Irshad H. Chaudry, PhD. Speakers include Ronald G. Tompkins, MD, Richard S. Hotchkiss, MD, Lyle L. Moldawer, PhD, and James A. Lederer, PhD. These experts will conduct debates on an important issue - whether or not animal models reflect human inflammatory diseases. The value of model organism in shock and trauma research will be discussed.

Tranexamic Acid (TXA) and Trauma Resuscitation,

co-chaired by Irshad H. Chaudry, PhD and Anthony Pusateri, PhD. Speakers include Todd Rasmussen, MD, Colonel, Ernest E. Moore, MD, Mitchell Cohen, MD and Anthony E. Pusateri, PhD. The presentations will be centered on the use of TXA in trauma and its potential beneficial and negative effects of TXA. The knowledge gaps and important areas for research will be discussed.

Plenary Abstracts, co-chaired by Basilia Zingarelli, PhD, MD (President), and Robert N. Cooney, MD (President-Elect). Speakers are the oral presenters of the seven top-scored abstracts. In addition, four Parallel Symposia have been organized to discuss a broad range of topics. Stem Cell Biology and Regenerative Medicine, co-chaired by James A. Cook, PhD and Ping Zhang, MD, PhD; Cytokine and *Chemokine Regulation*, co-chaired by Barbara Sherry, PhD and Edward R. Sherwood, MD, PhD; Microparticles, Inflammation and Shock, co-chaired by Charles C. Caldwell, PhD and Marc Maegele, MD, PhD; and Novel Anti-Infective Therapies, co-chaired by Michael A. West. MD. PhD and David J. Hackam. MD, PhD. The topics of four mini-symposia are Sepsis: Mechanism and Therapeutics, Trauma and Hemorrhagic Shock, Inflammation Signaling, and Ischemia-Reperfusion Injury.

We will have a lunch session on *How to Advance Your Academic Career: Not Only for Jr. Faculty* with topics include "Advancing Your Career in a Large Academic Medical Center" by Timothy R. Billiar, MD, and "Developing an Academic Career in a Medical School Setting: Opportunities and Challenges" by David L. Williams, PhD. In addition to the traditional *New Investigator Competition*, this year we will have presentations from research fellowship recipients, Daithi Heffernan, MD and Wendy Walker, PhD.

I would like to thank Scientific Program Committee members for their hard-work and Mary Schuerman of Strategem for her exceptional support. We look forward to seeing you in San Diego!

Preference will be given for new and innovative research, basic or translational, in the area of trauma, shock and/or sepsis.

I am happy to report that the Shock Society remains fiscally healthy. A detailed 2012 income and expense report will be provided to

Council and the membership at the Annual Meeting in San Diego, California this June.

As of February 2013, the Society boasts approximately \$1.3 million in total assets. Our funds are distributed over three FDIC banking institutions in a single checking and three money market accounts plus a 3 year CD held in a fourth bank. Nearly two years ago, the Society agreed to invest \$250,000 in a mutual fund with a strict stop-loss strategy. While on paper we sustained 10-15% losses during the economic recession, we are nearly back to baseline and, assuming the market continues to thrive, should soon realize actual gains. Our strategic plan is to access gains as they accrue and utilize these toward travel and fellowship awards.

Income from the Journal continues to be our primary source of revenue, realizing approximately \$160,000 for 2012. Our primary expenses include our Strategem commitments, Journal subscriptions for members, and meeting costs. The International meeting last year was particularly expensive (though I am not really complaining as we reaped the benefits of a number of excellent speakers and the participation of our Shock Society partners around the world). Despite our fiscal health, we continue to look to our members for additional vendor contacts and support to offset our meeting expenses. If you know of companies that might be interested in a small, focused, scientific venue, please forward these to Dr. Zingarelli or Dr. Cooney.

This year marks the end of my tenure as Treasurer. It has been my honor and pleasure to serve as an officer in the Shock Society. The Society means a great deal to me and I am pleased to know that the treasury will be in excellent hands (two fabulous candidates for the job – be sure to vote!).

I am thankful to Connie Weldon and Dennis Campbell who have and continue to provide tremendous help in all aspects of the journal. My special thanks go to Mr. John Ewers, our Senior Publisher, and to Rosemary Hutzler, our Production Editor, Lippincott Williams & Wilkins (LWW), for their continued kind help pertaining to all aspects of publication.

I am pleased to inform you that the Publication Committee Chair, Dr Charles Lang, and the Committee approved the appointment of Ronald Maier and Patricia Molina as Associate Editors. The following individuals have agreed to serve on the Editorial Board of *SHOCK*, effective 2012 and some in 2013.
